**(Approve Allied Agreements)**

UPON the application of Hardie & Kelly Inc. ("the Receiver") in its capacity as Receiver of Liberty Graphics Ltd. ("Liberty"); AND UPON hearing read the Affidavit of A. Ronald Hardie sworn March 6, 2009 ("the Hardie Affidavit"), filed; AND UPON hearing counsel for the Receiver and counsel for Allied Printers and Promotions (Alberta) Ltd. ("Allied"); AND UPON it appearing that approval of the agreements described herein is in the best interests of the creditors and stakeholders of Liberty;

IT IS HEREBY ORDERED THAT:

1. Subject to paragraph 4 hereof, service of notice of this application and supporting materials is hereby declared to be good and sufficient, and no other person is required to have been served with notice of this application.
2. Subject to paragraph 4 hereof, the Assignment Agreements, as that term is defined in and which are Exhibits "A" and "B" to the Hardie Affidavit, are hereby approved.
3. Subject to paragraph 4 hereof, the Receiver is hereby authorized to conclude the transactions contemplated by the Assignment Agreement and to take all such steps and

execute all such documents as may reasonably be necessary to complete the transactions contemplated therein.

4. A copy of this Order, the associated Notice of Motion, and the Hardie Affidavit shall be substitutionally served on Brian Kerr ("Kerr") by:

- (a) placing copies of same in a sealed envelope and posting same to the door at 1206, 1620 - 70 Street S.E., Calgary, Alberta, in which case service will be deemed to have been effected on Kerr on the day of such posting, and ~~at~~ *in*
- (b) mailing copies of same by prepaid regular mail to 1206, 1620 - 70 Street S.E., Calgary, Alberta, T2A 7Y6, in which case service will be deemed to have been effected on Kerr three business days following the date of such mailing,

and such service shall constitute good and sufficient service of such documents on Kerr. Kerr shall be at liberty to bring such application ("the Come-Back Application") as he considers appropriate to seek to have the approvals and authorizations set out herein set aside, provided that any Notice of Motion and supporting Affidavit for any such application shall be filed and served on counsel to the Receiver by not later than ~~one week~~ *10 days* from the date of service of such documents, failing which such approvals and authorizations as are set out herein shall be final. If Kerr files and serves the materials for a Come-Back Application as set out herein, such application will be heard and determined as expeditiously as practical.

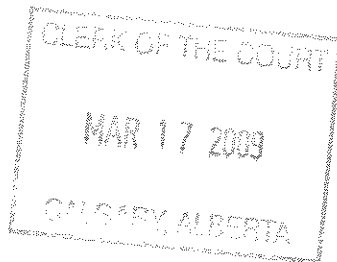
