**ORDER**

**UPON THE APPLICATION** of the Proposal Trustee, Hardie & Kelly Inc. (the "Proposal Trustee") for an Order approving the Proposal of Accurate Logistic Solutions Inc. ("Accurate") filed with the Office of Superintendent in Bankruptcy / Official Receiver on November 23, 2009 and accepted by the requisite majority of Accurate's creditors at the meeting of creditors held December 10, 2009 (the "Proposal"); **AND UPON HEARING READ** the Report of the Trustee on Proposal dated December 10, 2009, filed (the "Proposal Trustee Report"); **AND UPON HEARING** from the Proposal Trustee, and counsel for Accurate; **AND UPON HEARING** that the Proposal has been accepted by the required majority of the creditors of Accurate; **AND UPON BEING SATISFIED THAT** the Proposal is: i) reasonable, ii) calculated to benefit the general body of Accurate's creditors, and ii) made in good faith:

1. The time for service of the Notice of Hearing of Application for Court Approval of Proposal and the Proposal Trustee Report herein be, and it is hereby abridged, to the date of actual service and that the service, including the manner of service of the application materials, be and is hereby approved and validated, that the application is properly returnable today and that all parties entitled to notice of this application have been properly served and further service thereof is hereby dispensed with.

2. The application is properly returnable today notwithstanding that the time requirements of Section 58 of the *Bankruptcy and Insolvency Act*, R.S.C. 1985 c. B-3 (“*BLA*”) have not been complied with.

3. The Proposal is hereby approved.

4. The Proposal Trustee is hereby directed to pay all amounts to all creditors of Accurate who have filed approved claims in accordance with the terms of the Proposal.

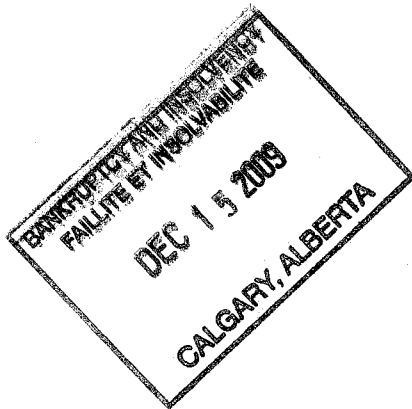
