**ORDER**



2. The Monitor is directed to mail the Plan of Arrangement, Notices of Meeting and forms of Proxy as approved by this Court to all creditors affected by the Plan, at their last known address;

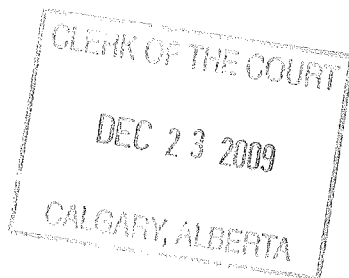
