

UPON THE APPLICATION FOR BANKRUPTCY ORDER filed by 888888 Alberta Ltd., filed the 5<sup>th</sup> day of November, 2009; AND UPON HEARING READ the petition and Affidavit of Joshua Summerland, filed in support thereof, AND UPON HEARING the representations of Counsel for the Applicant and any other counsel appearing at the hearing of the within Petition; AND UPON IT APPEARING to the Court that the following act of bankruptcy has been committed, namely:

- a) During the six months next proceeding the date of the filing of the said Petition and prior thereto, Clinitrust Global Inc. ("Clinitrust") had ceased to meet its liabilities generally as they became due and in particular failed to pay the debts owing to the Applicant.

IT IS HEREBY ORDERED AS FOLLOWS:

- 1. Clinitrust, a body corporate duly incorporated under the laws of the Province of Alberta and having offices in the City of Edmonton, be and is hereby adjudged bankrupt and a Bankruptcy Order is hereby made against the said Clinitrust;

4. The costs of and incidental to the within Application and Bankruptcy Order shall be paid to the Applicant out of the assets of the bankrupt's estate without the necessity of a taxation.
