(Extension of Stay to July 5, 2010)**

**TAKE NOTICE** that an application will be made on behalf of Darian Resources Ltd. ("Darian") and Bowview Petroleum Inc. (collectively the "Applicants") before the Honourable Madam Justice B.E.C. Romaine in Chambers, at the Calgary Courts Centre, in the City of Calgary, in the Province of Alberta, on Thursday, June 24, 2010 at 1:00 o'clock in the afternoon or so soon thereafter as counsel may be heard for an Order extending the Stay Period as defined in the Initial Order granted in these proceedings on February 12, 2010 to and including July 5, 2010.

**AND FURTHER TAKE NOTICE** that the grounds upon which this application is based are:

- (a) the Applicants are moving forward with steps to determine the nature and the quantum of creditors claims outstanding against them;
- (b) the Applicants have obtained a Creditors' Meeting Order with respect to approval of a CCAA plan of arrangement;

- (c) Darian has obtained an Interim Order with respect to having its shareholders consider a Plan of Arrangement pursuant to section 193 of the *Business Corporations Act* (Alberta);
- (d) the Applicants have acted, and are continuing to act, in good faith and with due diligence in these proceedings;
- (e) it is appropriate that the Stay Period be extended to July 5, 2010 in order that the Applicants can work towards the approval and implementation of a plan of arrangement or compromise.

**AND FURTHER TAKE NOTICE** that in support of this application will be read the pleadings in this action, the Affidavit of Grant Bartlett sworn June 18, 2010, the Monitor's Seventh Report filed in these proceedings, the *Companies Creditor's Arrangement Act*, the *Alberta Rules of Court*, and such further and other material as counsel may advise and this Honourable Court permit.
